- 1. Welcome Visitors: none
- 2. Agenda approval/additions: none
- 3. Review and approval of July notes: Amended notes (rev 2) approved.

4. Financial report

Kae briefly shared the financial report - no modifications required. Rosean noted that the CD matures in August and asked whether it can be renewed or the amount deposited should be changed. Consensus was to renew the full \$10K.

5. **Bishop's report:** see Appendix A.

Christy Chady's ordination is a "go" on Saturday, Aug 3. The Process Review is currently stalled. Kae will update us as more information becomes available. July was a month of fun events.

6. Vicar's report: see Appendix B

Michael built templates for our RMRC meeting agendas and minutes and distributed them via e-mail along with July's notes on 7/6/24. He was asked to provide a link to the LGBTQ Discrimination in the Workplace guide on our regional webpage but felt that sharing this information on social media might be more appropriate and get the information to a broader audience. Alice thanked Michael for posting information about Christy's upcoming ordination to the regional website. A brief discussion ensued on how long articles should be retained on the RMR website home page. Alice suggested a reordering of the articles to ensure that links to timely, relevant and quality recordings appeared first.

7. Leadership Council Report

Chuck reported that Teri has been away and there is no Leadership Council report this month. (As a sidebar, Teri's health has been improving and she is working with doctors to wean her off oxygen especially at night.)

Old Business

1. Holy Synod Oct 11-14, 2024 planning and support

Drivers for delegates from DIA to LOC (or YMCA) remains an urgent need. Each community should try to recruit additional help. Tom provided a brief summary of the planning meeting held on July 23. The committees are all actively making progress. Jane reported the Truth and Reconciliation commission will have a table at Synod. Folks not staying at the Y overnight but who wish to purchase meals can do so for \$9/meal. Kae is coordinating hosting of bishops who will remain until Wed after Synod for a short retreat. RMRC Synod scholarships: 2 for delegates (1 full, 1 partial) and 2 for non-delegates (both partial) have been granted. Some funds remain for Synod scholarships. RMR delegate registration is well underway.

- 2. **Accountability Calendar** Nothing shown for August. Kae asked about community support for the Mary Magdalene Society. Each community seems to have supported the campaign either by a community donation from leadership, by individual donations, or both.
- 3. Marketing Discussion Follow-up on Liz's communications with Aaron Baily Chuck contacted LOC marketing folks who spoke to Aaron about responding to Liz. Aaron has also been unsuccessful reaching her. Some brief discussion about whether the scope of work for a region falls outside of Aaron's expertise. Chuck will try one more time to initiate email communications between Liz and Aaron. Michael noted that Aaron will need some sort of understanding about the diversity in our regional communities and defining that would be beneficial for our respective websites also.
- 4. **Certificates for Ethics Training:** Rosean reminded all clergy to send copies of certificates for training to her. Overall, the continuing education expectation is 10 hrs for priests, 5 hrs for deacons.
- 5. **Christy Chady's Ordination**: A quick reminder and invitation for all to attend this Saturday at 9:00 am. Kae has distributed information via e-mail.

New Business

1. Community Updates

- COB: has an ordination. Individuals have been supporting a refugee family of 4. Will do annual rice and beans on Oct 5 at 3:30. Invite youth from other parishes.
- CHF: Janes shared stories of a Venezuelan her son hired and an encounter with a woman with 3 kids from Ukraine. Such a struggle for refugees and asylum seekers face-to-face "welcoming" really counts. Liturgy committee discussion around inclusive language.
- MoM: Jared Orsi and Ruth Alexander will present their respective books Aug 29 the books include emphasis on Social Justice. Rosean has been diagnosed with invasive cancer, requests prayers, and notes some changes necessary for the MoM community especially during radiation treatments. The parish Leadership Council will have a retreat on Aug 17.
- SP: Celebrating host church's 100th anniv. Invited by their host church on Aug 17 to a discussion about the building's future and emerging uses. It is good to be included in giving voice to defining that vision.
- LOC: Kids coming back from Pine Ridge writing up experiences which someone from National ECC is documenting. Kids will be giving the homily on their trip this weekend.


